

## Historic Senate Passage of the Great American Outdoors Act is Celebrated by Groups Across the Nation

“Today the Senate delivered a historic win for the conservation of America’s natural landscapes,” said **Jennifer Morris, chief executive officer at The Nature Conservancy**. “This bill would make major investments in the landscapes and landmarks vital to our economic, emotional and societal well-being. By protecting important natural spaces and investing in their care, this bill will help create jobs, rebuild local economies and expand access to the outdoors that everyone has a right to enjoy. Today’s vote puts us one step closer to fulfilling a vision set out by President Kennedy over 50 years ago, to conserve the natural resources that belong to everyone. The Land and Water Conservation Fund has helped preserve forests, open spaces, watersheds and other landscapes in every state at no cost to the taxpayer. Today’s large, bipartisan vote is an affirmation of the broad support for common-sense, effective investments in America’s outdoors. We thank our many conservation champions for making today’s vote a reality, and we urge the House to quickly follow suit.”

“It’s not often that lawmakers can say they helped pass legislation that will have an impact decades into the future, but today’s vote on the Great American Outdoors Act is one they can tell their grandchildren about,” said **Marcia Argust, project director of The Pew Charitable Trusts’ Restore America’s Parks campaign**. “The House of Representatives must step up and act next, so that our national parks and public lands can be repaired, restored, and protected for future generations.”

“People across the country need healthier, safer and better access to public lands, parks and outdoor spaces where we can build community and care for ourselves physically and emotionally. The need to safeguard the funding that goes towards our public lands, ensure they are protected and maintained, and guarantee we are providing safe, welcoming opportunities for all people to benefit from them is more urgent than ever,” said **Jamie Williams, President of The Wilderness Society**. “Today’s Senate passage of the Great American Outdoors Act gets us a step closer to Congress keeping a promise to the people it serves to invest in the natural, cultural and recreational resources that anchor our communities. We now call on the House to keep up this energy and quickly get the Great American Outdoors Act to the President’s desk, and with it, finally get full, permanent funding for the Land and Water Conservation Fund over the finish line.”

A product of years of bipartisan collaboration, this landmark conservation bill would make significant investments to tackle our parks’ deferred maintenance needs. The Great American Outdoors Act not only provides an opportunity to better care for our national parks, it will help conserve and increase access to public lands across the country and provide jobs in communities that desperately need them. Members of Congress must work together to get this bill over the finish line in the House and ensure our children and grandchildren can experience and enjoy these treasured places now, and for years to come.”

“The Great American Outdoors Act will provide the largest investment in our nation’s historic and cultural resources in more than a generation. The nearly \$12 billion National Park Service deferred maintenance backlog, of which 47% is for historic assets, puts historic buildings and other infrastructure at risk of permanent damage or loss. This legislation would provide \$9.5 billion in dedicated funding over five years for much needed repairs of the National Park Service and other federal agencies. And permanent full funding of the Land and Water Conservation Fund will ensure that the source of funds used to protect such iconic places as Martin Luther King, Jr. National Historical Park, Chaco Culture National Historical Park, and Valley Forge National Historical Park will continue into the future,” **said Tom Cassidy, Vice President for Government Relations and Policy at the National Trust for Historic Preservation.**

It is time to come together, seek reconciliation, and find healing as we face the COVID-19 pandemic while once again confronting our greatest national sin—racism. “The maintenance bill for our nation’s parks is overdue,” said **K.N. Gunalan “Guna”, Ph.D., P.E., President, American Society of Civil Engineers**. “At a time (before the global pandemic) when Americans were spending more time in our parks—spending nearly \$900 billion in annual outdoor recreation, the National Park Service had a deferred maintenance backlog of nearly \$12 billion.
